Dear Sir or Madam,

Your company has released information about my firm that is defamatory in nature and has caused my firm significant economic harm. This information can be found at the following link(s):

Among numerous false claims made by your company, you allege that my firm was engaged in violating thousands of copyrights when, in fact, we had not received even a single DMCA, Cease and Desist, or other formal allegation even alleging that we were infringing on a single copyright-let alone been found liable in court for such an infringement.

Your misrepresentation of our firm caused us to lose an entire product line that was proving to be very profitable in its test phase (see Exhibit One). This product line on one outlet alone, eBay.com, was projected to generate \$2,000,000 a month in gross profits within one to two years. The present value of this revenue stream over the next decade was well over \$100,000,000 and could have been as high as \$200,000,000 depending on the discount rate utilized. My firm had the equipment, personnel, and experience to realize the profits from this product line before the defamatory information released by your firm caused our permanent suspension from eBay.com. (see Exhibit Two)

In addition to the lost product line, my firm was also damaged by losing a contract that would have been worth \$10,000/year in gross profit to us, losing two advisors from our board of directors who did not wish for any further negative press to mention them, losing untold business from having your defamatory information listed right below our website in online search engine results, losing at least one potential employee, losing investment opportunities, having untold damage done to our brand and our employees' reputation, and having numerous death threats and pejorative remarks levied at anyone/any firm associated with my firm.

As my firm is not a large firm, we do not have the funds required for properly redressing this enormous harm done to us by your company's complete and utter reckless publishing of defamatory material and subsequent refusal to retract said information. However, at the very least we are asking the State of Pennsylvania to grant us the \$12,000 that Small Claims Court allows us to request.
